GUIDLINES

1. Before an aerodrome certificate is granted the Maldives Civil Aviation Authority will require to be satisfied that the physical conditions on the manoeuvring area and in the environs of the aerodrome are acceptable, that the scale of equipment provided is adequate, and that the aerodrome is organized, staffed and has maintenance and other arrangements sufficient ensure the safe operation of the aerodrome and its facilities for the purposes for which the certificate application has been made. The requirements are set out in detail in the Maldivian Civil Aviation regulation (MCAR) 139.
2. Before submitting this application, the authorities as indicated below should be consulted and their correspondence should be attached.
 - i) Ministry of Tourism Arts and Culture
 - ii) Ministry of Fisheries and Agriculture
 - iii) Environmental Protection Agency
 - iv) Ministry of defense and National Security
3. Two copies of the Aerodrome Manual, prepared in accordance with the Standards in the ASC 139-5 (Aerodrome Standards Manual) is required as part of this application.
4. Two copies of the Safety Management System Manual, prepared in accordance with the CAR Part 21 (Civil Aviation regulation) is required as part of this application.
5. Two copies of the Airport Emergency Plan Manual, prepared in accordance with the Airport Services Manual Part 7 is required as part of this application.
6. One copy of the Airport security programme (ASP) in accordance with the National Civil Aviation Security Programme (NCASP) Part B, Section 6.3 is required as part of this application.
7. The cost of Aerodrome Certification shall be recovered in accordance with the MCAR 187 rates as provided in the scheme of charges.
8. Documentary evidence in support of all the matters in this application may be provided if requested.
9. Completed forms should be submitted to the Chief Executive officer, Maldives Civil Aviation Authority (MCAA).
