GUIDLINES

1. Before a platform license is granted the Maldives Civil Aviation Authority will require to be satisfied that the physical conditions of the aerodrome and the surrounding environment of the aerodrome are up to standard. The requirements are set out in detail in the Air Safety Circular (ASC) 139-2.
2. This application must be accompanied by an areal map showing the exact boundaries of the proposed platforms and the mooring positions. True north arrow shall be marked on the map.
3. Before a license is issued a line inspection will be conducted with the below listed authorities
 - i) Ministry of Tourism Arts and Culture
 - ii) Ministry of Fisheries and Agriculture
 - iii) Environmental Protection Agency
 - iv) Ministry of defense and National Security
4. The cost of Aerodrome License shall be recovered in accordance with the MCAR 187 rates as provided in the scheme of charges.
5. Documentary evidence in support of all the matters in this application may be provided if requested.
6. Completed forms should be submitted to the Chief Executive officer, Maldives Civil Aviation Authority (MCAA).
