### CHANGES TO IATA TTBS: MALDIVES AIRPORT FEE - BQ

#### 1.0 GENERAL

**1.1** The provisions and application of the 10<sup>th</sup> amendment to Law Number 71/78, revising the Airport Service Charge had been notified vide Air Transport Circular AT 03/09 – Issue 01 dated 09 December 2009.

Subsequently, International Air Transport Association (IATA) has made the necessary amendments to Maldives Airport Fee – BQ and updated the Ticket Tax Box Service (TTBS) database to facilitate the collection of the revised Airport Services Charge at point of sale.

#### 2.0 PURPOSE

**2.1** The purpose of this Circular is to advise airlines and airport authorities of the changes made by IATA to TTBS database with regard to Maldives Airport Fee (BQ).

#### 3.0 REQUIREMENT

**3.1** Airlines operating international flights to/from Maldives and airport authorities are advised to take note of the following changes made to IATA TTBS: Maldives - Airport Fee – BQ;
